



ACCREDITATION STANDARDS 2022

Summary of major changes to the ACSA Standards document (Domains 1–4)

This document summarises the major changes to the 2021 ACSA standards following extensive consultation and review.

Domain 3 (patient experience) has undergone significant revision in order to improve clarity and reduce duplication between standards. Whilst the numbering and wording of standards has changed, the overall requirements in this domain remain the same as in 2021 and thus the domain 3 standards continue to be priority 1.
